



# Transferring to Oklahoma State University

Deadlines to submit the Undergraduate Application for Admission and Scholarships: **Fall-entering students: February 1 for priority consideration; July 1 final deadline. Spring-entering students: October 15 final deadline.**

| <b>REGENTS DISTINGUISHED TRANSFER WAIVER</b> ( <i>Oklahoma residents only</i> )   |                               |  |
|   | <b>Up to \$2,500 per year</b> | Tuition scholarship is renewable for up to two years with a 3.0 cumulative graduation/retention GPA. Recipients must earn a minimum of 28 credit hours each year (fall/spring). No academic area of emphasis required. <b>Eligible students must have 24+ transferable hours and a 3.25 college GPA.</b>   |
| <b>TRANSFER NONRESIDENT ACHIEVEMENT SCHOLARSHIP*</b> ( <i>Nonresidents only</i> ) |                               |  |
|   | <b>Up to \$5,000 per year</b> | The Transfer Nonresident Achievement Scholarship is renewable for up to two years with a 3.0 cumulative graduation/retention GPA. Recipients must earn a minimum of 28 credit hours each year (fall/spring). No academic area of emphasis required. <b>Eligible students must have 24+ transferable hours and a 3.25 college GPA.</b>              |
| <b>TRANSFER NONRESIDENT LEGACY SCHOLARSHIP*</b> ( <i>Nonresidents only</i> )      |                               |  |
|   | <b>Up to \$5,000 per year</b> | Transfer Nonresident tuition scholarship is renewable for up to three years with a 3.0 cumulative graduation/retention GPA and 28 hours earned each year. Student must be a child/grandchild of OSU alumnus who earned a bachelor's degree or higher at OSU. Qualifying parent/grandparent alumnus must have graduated before student attends OSU. |

\*Students eligible for both the Transfer Nonresident Achievement Scholarship and the Transfer Nonresident Legacy Scholarship will receive the scholarship that provides the greatest benefit to the student.
